I appreciate you are acting on behalf of the RAPPS.

I believe I have been open and transparent with all communique from your members. My statements and decisions on the ILS have not changed. You should have that detail from Open Council meetings and my reply to the Ratepayers Association through the Daily's Letter To The Editor.

I support a flying school present or future for our airport and agree to current structure.

I instructed council on two occasions to seek legal advice around the Mayor participating in discussion on the ILS in connection with the budget. On both occasions the legal advice agreed that councils internal procedures and process of separating any ILS discussion and subsequent budget discussion cleared the Mayor of any conflict in participating in deliberations.

I also made the community aware of that process by having it clarified by Mr Sexton in Open Council Meeting, transcript available.

I concede from a personal perspective that I don't believe the Mayor should have accepted the CEO position at the IAA Pty Ltd.

On the noise issue - I supported further investigations that were carried out by council and the flying school to minimize resident reports. As a consequence changes were made and you have been supplied with that information and further information available on the Airport Q & A page. I also know residents in those flight paths and they reported lessening of the noise component.
